- All displays must be removed by 4:00 PM on Thursday, April 23, 2026.
- Displays over 5' by 7' in dimension require prior approval. If your display requires floor space on the side or the front of the table, dimensions must be provided and are subject to approval prior to the day of the event. Please note on your application if power is needed for your booth.
- ATAA/ANVCA and the Marriott reserve the right to request display materials that exceed the 6' table be removed.

Space is limited and exhibit tables are reserved on a first come, first serve basis on acceptance of your application. The Board reserves the right to refuse any vendor it determines as not appropriate for the conference. Payment of \$2,000 must accompany application to reserve your exhibit space.
